PUBLIC PARTICIPATION (2-3 MINUTES PER PERSON)

- (a) Members of the public may address the City Council in accordance with Section 2.06(g) of the Illinois Open Meetings Act (5 ILCS 120/2.06(g));
- (b) Public comments are limited to three (3) minutes per speaker;
- (c) The subject of public comments shall be reasonably related to matters(s) identified on the meeting agenda and/or other city business;
- (d) Repetitive public comments should be avoided, to the extent practical, through adoption of prior public comment (e.g. agreeing with prior speaker);
- (e) The following conduct is prohibited during public participation:
 - Acting or appearing in a lewd or disgraceful manner;
 - Using disparaging, obscene or insulting language;
 - Personal attacks impugning character and/or integrity;
 - Intimidation;
 - Disorderly conduct as defined in Section 130.02 of this revised code of ordinances.
- (f) Any speaker who engages in such prohibited conduct during public participation shall be called to order by the chair or ruling by the chair if a point of order is made by a sitting alderman.

Proclamation

Whereas, April 1, 2020, is Census Day for the United States of America pursuant to Article 1, Section 2 of the U.S. Constitution; and

Whereas, the Census count requires extensive work, and the Census Bureau requires partners at the state and local level to ensure a complete and accurate count; and

Whereas, an accurate and complete Census count is important to the City of Belleville in determining Federal dollars for health, education, transportation, child and elder care, emergency preparation and response, and public and social health programs. The City receives a large portion of our General Fund revenues from the State based on population, including State Income Tax and State Use Tax. These revenues are used to support general operations of the City, including public safety and public works departments. The City also receives Motor Fuel Tax from the State based on population. These funds are used for infrastructure maintenance and repairs throughout the City; and

Whereas, establishing a Census 2020 Complete Count Committee will allow the City of Belleville to obtain the most accurate and complete population count for the decennial Census in 2020; and

Whereas, the City of Belleville Complete Count Committee will bring together a cross-section of community members who will utilize their local knowledge and expertise to reach out to all persons of our community; and

Whereas, all members of the Complete Count Committee and the Census Bureau are bound by Title 13 of the United States Code to keep all information and data confidential and protected to ensure the privacy and protection of all residents; and

Whereas, the City of Belleville Complete Count Committee will work with the Census Bureau and the State of Illinois to strive for an accurate count.

NOW THEREFORE I, Mark W. Eckert, Mayor of the City of Belleville, do hereby proclaim full support and participation in the overwhelming success of Census 2020 through the formulation of a **COMPLETE COUNT COMMITTEE**.



ORDINANCE NO. 8398-2019

AN ORDINANCE AMENDING SECTION 33.085 (FIRE CODE ADOPTED) CHAPTER 33 (PUBLIC SAFETY; LAW ENFORCEMENT) OF THE REVISED CODE OF ORDINANCES OF BELLEVILLE, ILLINOIS

THE CITY OF BELLEVILLE, ST. CLAIR COUNTY, ILLINOIS (THE "CITY"), IS A DULY ORGANIZED AND EXISTING MUNICIPALITY CREATED UNDER THE PROVISIONS OF THE LAWS OF THE STATE OF ILLINOIS.

THE CITY OF BELLEVILLE IS NOW OPERATING UNDER THE PROVISIONS OF THE ILLINOIS MUNICIPAL CODE, AS SUPPLEMENTED AND AMENDED AND AS A HOME RULE MUNICIPALITY PURSUANT TO ARTICLE VII OF THE ILLINOIS CONSTITUTION OF 1970; AND IN THE EXERCISE OF ITS HOME RULE POWERS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BELLEVILLE, ILLINOIS as follows:

Section 1. That Section 33.085 (Fire Code Adopted) of Chapter 33 (Public Safety; Law Enforcement) of the Revised Code of Ordinances of Belleville, Illinois is hereby amended to state the following in its entirety:

33.085 FIRE CODE ADOPTED

(A) Adoption of Fire Prevention Code.

(1) There is hereby adopted by the city for the purpose of establishing rules and regulations to safeguard life, property and public welfare from the hazards of fire, and explosion arising from the storage, handling or use of substances, materials or devices and from conditions hazardous to life, property and public welfare in the use or occupancy of buildings, structures, sheds, tents, lots or premises, that certain code known as the 2015 International Fire Code and the whole thereof, save and except such portions as are hereinafter deleted, modified or amended, and the same are hereby adopted and incorporated as fully as if set out in length herein, and from the date on which this section shall take effect, the provisions thereof shall be controlling within the corporate limits of the city.

(2) *Amendments.* The 2015 International Fire Code are hereby revised and/or amended as follows:

(a) Wherever the term "fire code official" is used in the Code hereby adopted, it shall be held to mean the "Fire Chief, or their designee, of the City of Belleville, Illinois".

(b) Section 101.1. Wherever the word "NAME OF JURISDICTION" is used in the Code hereby adopted, it shall be held to mean the "City of Belleville, Illinois".

(B) *Adoption of Appendices.* Appendices A through H of the 2015 International Fire Code are hereby adopted and incorporated as fully as if set out in length herein.

Section 2. That conflicting ordinances or pertinent portions thereof in effect at the time this Ordinance takes effect are hereby repealed.
