Non-Highway Vehicle permits are valid from **May 1st through April 30th** of the following year. This fee can be paid at the City Clerk's Office located at 101 South Illinois Street, Belleville, IL. The fee can be paid by cash, credit card, or check. Please make checks out to 'The City of Belleville'.
3. The Non-Highway Vehicle permit must be clearly displayed on the rear of the vehicle (77.03 (c))
